Letter of Intent between

**Asian and Pacific Training Centre for Information and Communication Technology
for Development (APCICT) and
Sri Padmavati Mahila Visvavidyalayam (SPMVV),
(Women's University)

Tirupati, Andhra Pradesh, India**

This Letter of Intent (LOI) will develop a partnership for promoting digital skills among women entrepreneurs and other community beneficiaries in India. This LOI outlines the agreement of the parties to cooperate on joint ICT capacity-building activities as follows:

- APCICT and SPMVV shall jointly organize capacity-building activities, wherever relevant, including trainings, seminars, and workshops; and
- APCICT and SPMVV will cooperate in promoting joint capacity-building programmes and knowledge products.

The roles and responsibilities of APCICT shall consist of:

- a) Provision of experts, resource persons and/or technical advice in the development and conduct of training activities jointly organized with SPMVV;
- b) Involvement of SPMVV in other initiatives, wherever relevant, including regional dialogues, training of trainers, seminars and workshops organized by APCICT;
- c) Promotion of joint capacity-building programmes in India as well as in other parts of the Asia-Pacific region.

The role and responsibilities of SPMVV shall consist of:

- a) Provision of experts, resource persons and/or technical advice in the development and conduct of training activities jointly organized with APCICT;
- b) Involvement of APCICT in national initiatives, wherever relevant, including events, seminars and workshops organized by SPMVV;

c) Promotion of joint capacity-building programmes in India.

There will be no transfer of funds between the two organizations, and each organization will mobilize resources to ensure the necessary inputs are provided for purpose of successful conduct of the events.

APCICT and SPMVV confirm that they have adequate safeguarding policies and procedures in place to maintain a workplace free of any form of discrimination, harassment, including sexual harassment, and abuse of authority.

SPMVV may not use the United Nations or APCICT name or emblem without prior written consent. Nothing in this letter shall be deemed as a waiver of the United Nations Privileges and Immunities.

This Letter is intended to be a nonbinding statement and preliminary concept of the terms of the proposed activities. It is subject to the preparation of other agreements reflecting the terms and conditions set forth in this LOI and other terms that are agreed to by the Parties.


